VILLAGE PROPERTY ORDINANCE
ORDINANCE NO. 6

An ordinance to protect the public property belonging to the Village; to prohibit the destruction or damage of Village property; to provide for enforcement; to provide penalties for violation hereof; and to repel prior ordinances.

ARTICLE I

DESTRUCTION OF PROPERTY

Section 1.01 No person shall in any way damage, deface, or destroy any building, structure, equipment or other real or personal property belonging to the Village.

ARTICLE II

TREES

Section 2.01 No person shall remove, cut, or trim any tree or shrub located on Village property without first obtaining the written consent of the Village Council.

Section 2.02 Written consent of the Village council, for purposes of this Article II may only be granted by affirmative vote of the Village Council at a duly held meeting.

ARTICLE III

ENCROACHMENTS

Section 3.01 No person shall construct any temporary or permanent structure, fence, or drainage facility in such a manner as to encroach on Village property without first obtaining the written consent of the Village Council.

Section 3.02 Written consent of the Village council, for purposes of this Article III may only be granted by affirmative vote of the Village council at a duly held meeting.

ARTICLE IV

ENFORCEMENT AND PENALTIES

Section 4.01 Violation of this Ordinance shall be a misdemeanor which shall be punishable upon conviction thereof by a fine not to exceed five hundred dollars (\$500.00) and/or by imprisonment not to exceed ninety (90) days.

ARTICLE V

SEVERABILITY

Section 5.01 This Ordinance and the various articles, sections, paragraphs and clauses thereof, are hereby declared to be severable. If any article, section, paragraph, or clause is adjudged unconstitutional or invalid, the remainder of the Ordinance shall not be affected thereby.

ARTICLE VI

REPEAL OF PRIOR ORDINANCE

Section 6.01 The Ordinance to Provide for Protection of Building and Lands, adopted February 22, 1974, is hereby repealed.

ARTICLE VII

ENACTMENT AND EFFECTIVE DATE

Section 7.01 This Ordinance adopted by the Village council of the Village of Otter Lake, Lapeer County, Michigan, at a meeting duly called and held on the 17th day of July, 1978, and us ordered to be given publication in the manner prescribed by law. This ordinance shall take effect thirty (30) days following publication thereof. __
